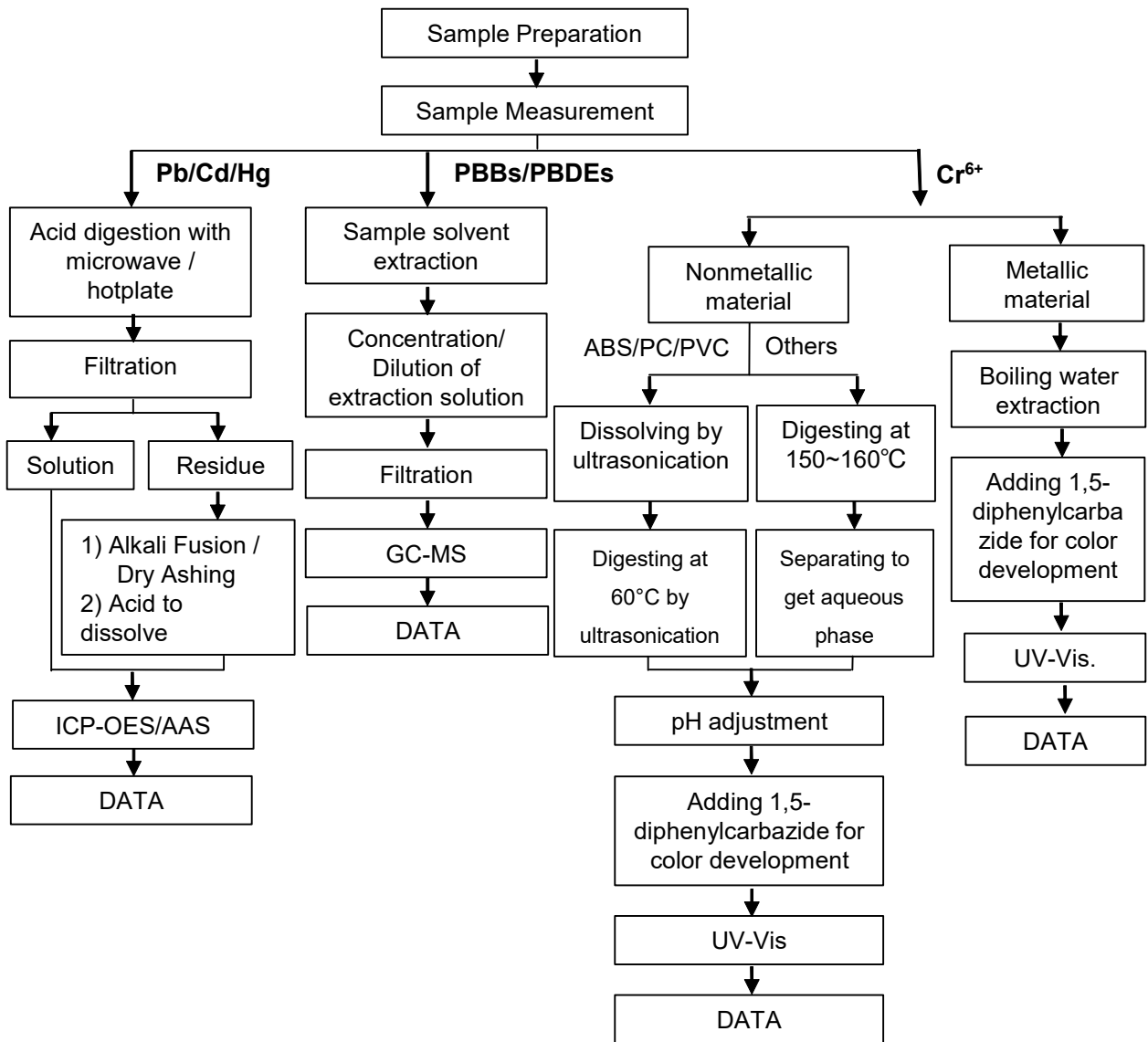

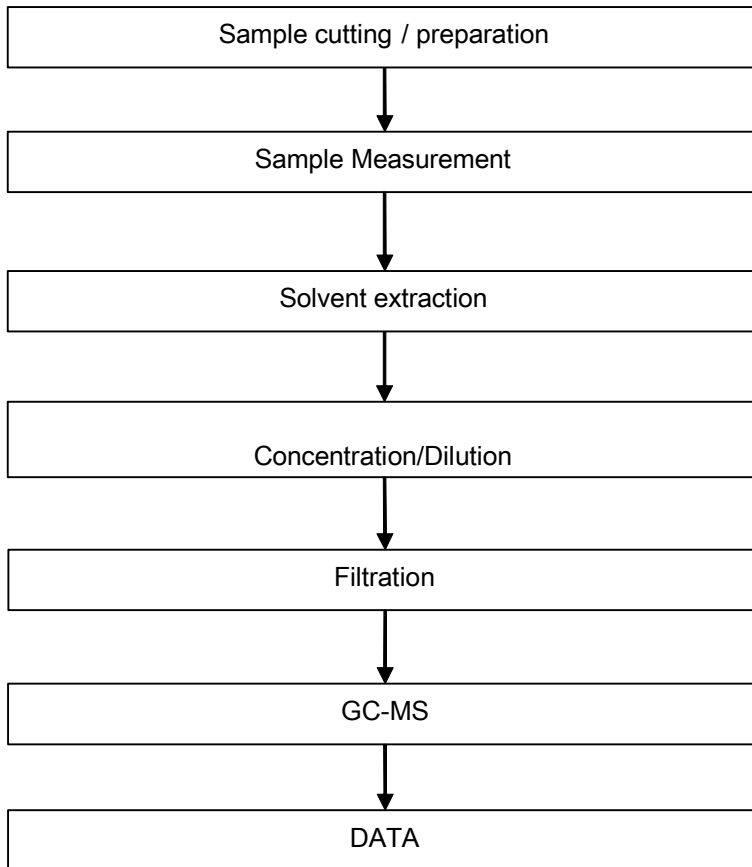

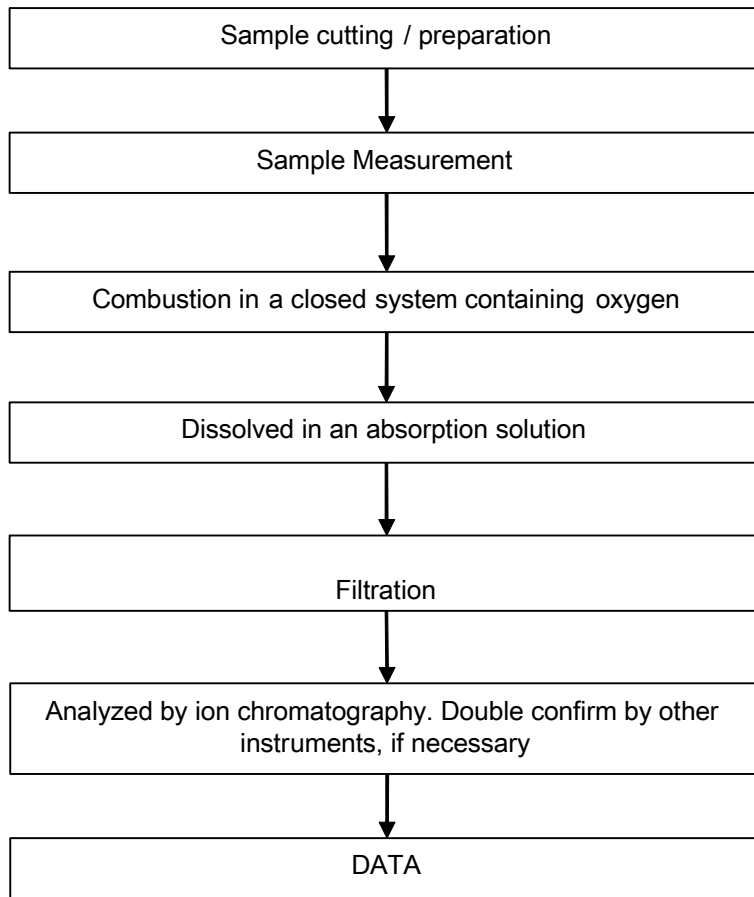
Phthalates Testing Flow Chart

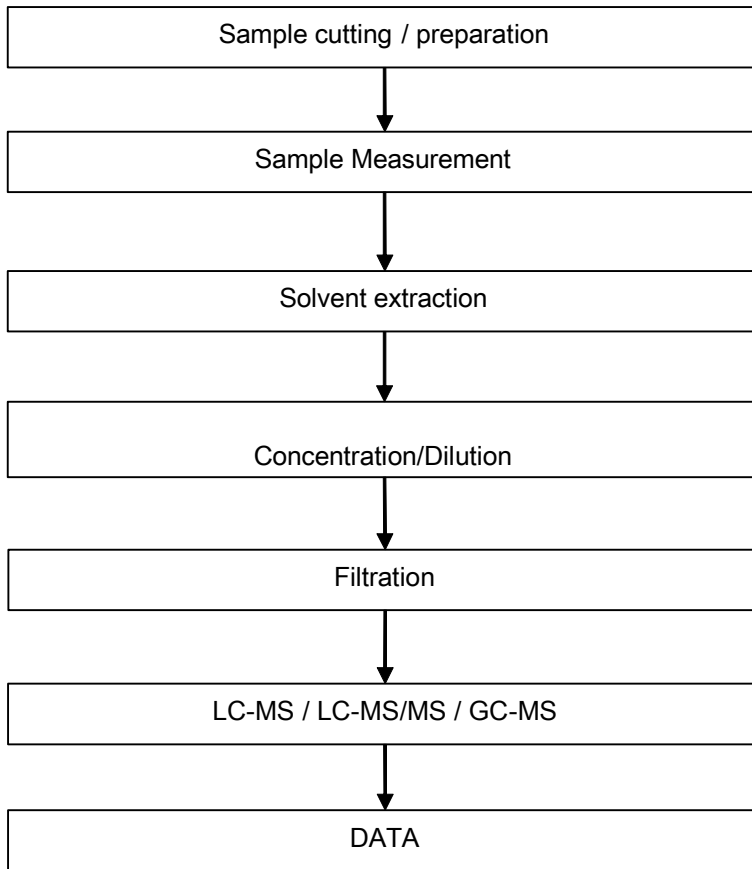
Halogen Testing Flow Chart

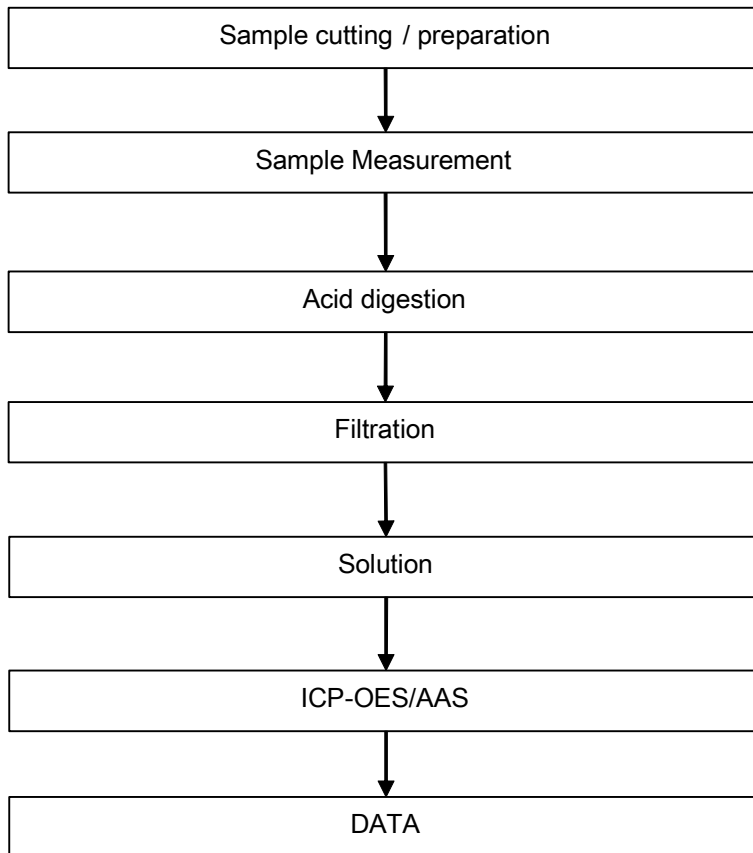
PFAS Testing Flow Chart

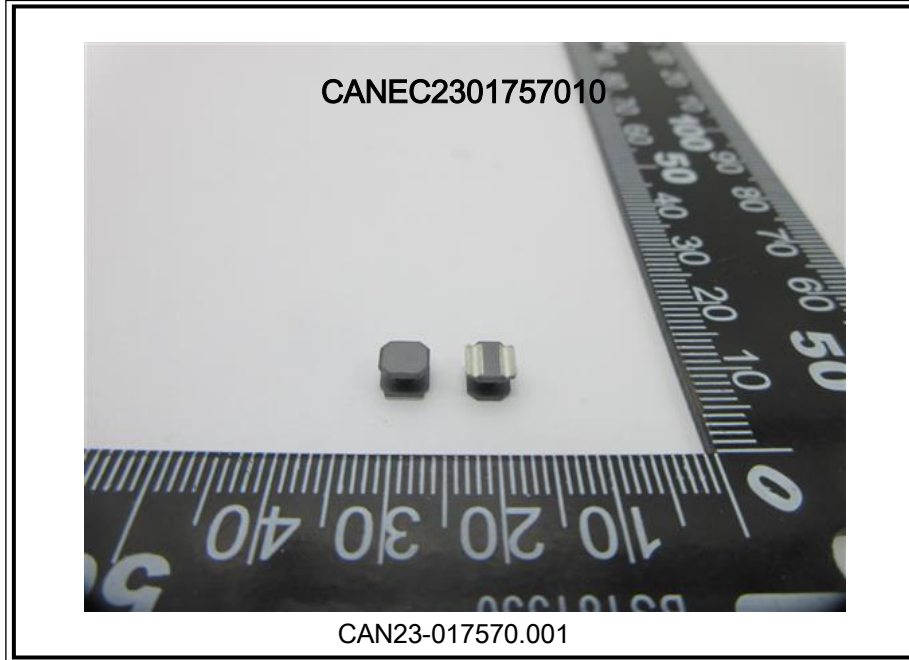
